## **Membership terms and conditions:**

Terms and conditions of membership and use of the course by members & guests:

1. *Rules and etiquette: Members will at all times observe the rules and etiquette of the game as outlined in the Royal and Ancient 'Rules of Golf' publication (available on request).*
  - a. *All golf will be played within the rules of golf as laid down by the R&A unless a specific event outlines a variation.*
  - b. *In addition, course users will observe the 'local rules' as laid down by the club.*
2. *Health and Safety: Members will observe the health and safety guidance for safe use of the courses, clubhouse and car park as published by the golf club, members should make their guests aware of our H&S advice, a full copy of which is available on request, but specifically:*
  - a. *Players should at all times be alert to the dangers of slips and trips on the golf course especially banks, slopes and damage caused by burrowing animals.*
  - b. *In addition players should assess the dangers associated with underfoot conditions particularly when wet or after wet conditions and especially during frosty or icy times of the year.*
  - c. *Players should always use pathways where provided.*
  - d. *Players should always ensure that appropriate footwear is used and that spikes or cleats are in good condition.*
  - e. *Players should also be aware of the use of the warning word FORE and the dangers of possible errant golf shots played by other users of the course.*
  - f. *Players are also advised to leave the course in the event of dangerous weather conditions including lightning or the potential of lightning as well as fog or conditions where they are unable to see other users such that they cannot make a safe decision to hit their next shot or continue playing safely.*
  - g. *Public footpaths and byways:*
    - i. *Footpath PF1666 is clearly defined and runs between 17 and 18, around the west side of the buildings then runs beside the 15<sup>th</sup> green and approach before crossing the 15<sup>th</sup> fairway and running between the 15<sup>th</sup> and 14<sup>th</sup>, it then runs beside the left of 5<sup>th</sup> before leaving the golf course. Players should at all times be aware of footpath users and give them priority allowing them to be a safe distance away before hitting any shot that could be dangerous.*
    - ii. *Public Byway PB1668 is clearly defined and crosses fairways 4 and 7 players should give priority to users before hitting any shot that could be dangerous to users of the byway.*
3. *Dress code: Smart casual golfing attire is required for use of the course and facilities, smart tailored shorts are acceptable.*
  - a. *Players are not permitted to wear T-shirts or shirts without collars.*
  - b. *Players are requested to wear golf shoes on the course.*
  - c. *The above is for guidance only and can be varied by the club if necessary.*
4. *Tee times: Play will only be allowed after registering your attendance on site at reception. Play should be reserved by name via any of the booking portals and confirmed on arrival.*
5. *Dogs are allowed on the course but must be under control and on a lead at all times. Dogs are not allowed in the clubhouse.*
6. *Credit: Any outstanding debt to the club must be settled before leaving the premises unless by agreement with the club.*
7. *Handicaps: All members are obligated to conform to the regulations as laid down CONGU in respect of gaining and maintaining a handicap but specifically:*
  - a. *Informing Horsham Golf of any previously held handicap and CDH number.*
  - b. *Advising Horsham Golf of any 'away' qualifying event that they may participate in.*
8. *Members must have a paid subscription that is 'in date' at all times when playing the course.*
  - a. *Members may introduce guests at the guest rate if they are playing with that guest. Any one guest can only play at the guest rate 5 times in any one year.*
9. *Children:*
  - a. *Children under the age of 12 must be accompanied by an adult unless under the supervision of a staff member or teaching professional.*
  - b. *Parents or guardians are made aware that Horsham Golf is accredited as a 'Club Mark' establishment and details can be made available on request. This outlines the specific health and safety and good practise policies and procedures for all children attending.*
10. *Notices: Members should check the appropriate notices posted in the clubhouse before play.*
11. *Resignation: One month's notice is required to be given before resignation of membership.*
12. *Insurance: Players are advised that they should be insured against any damage or injury that could be incurred from an errant golf shot hit by them or for any negligent action by them whilst at Horsham golf and or playing the golf course.*
13. *The club takes no responsibility for the safety of any item i.e. clubs etc. left by users on the premises, the club takes no responsibility for users' cars or vehicles left in the car park or on the premises at any time.*
14. *The management reserve the right to close the course for whatever reasonable reason at any time whether this is due to ground conditions, inclement weather or other unforeseeable circumstance. Note this could apply particularly in the time ahead of the full 18 holes being open.*
